It was resolved at the Council Meeting on Wednesday to accept the tender from GPM Constructions for the Wonboyn Lake Boat Ramp & Jetty Reconstruction Project.

#### 14 November 2014 #24

GPM were the same contractor that successfully completed the Merimbula Public Jetty reconstruction in 2010 and the Merimbula Boat Ramp and pontoon reconstruction project in 2011.

Their tendered price was within the project budget, so the full scope of works will be undertaken as per the design. Works are scheduled to commence on 2 February 2015.

#### Southern Phone Grants Scheme

BVSC is one of 41 Councils who collectively own the Moruya based Southern Phone Company, and this year's dividend of \$196,105.32 has an additional \$25,000 for a local community grants scheme.
