Important Disposal Information

The Protection of the Environment Operations (Waste) Regulation 2014 requires the transport of asbestos waste in NSW to be recorded from the place of generation to its final destination. Operators must use the EPA's WasteLocate system to comply with these requirements.

If your load is over 100kg or 10m³ for sheet asbestos you must register you load with WasteLocate. Failure to do so is an offence.

Loads of asbestos are only accepted at Council's Central Waste Facility by prior appointment. 48 hours notice is generally required.

The following safety guidelines must be followed:

- Thoroughly wet each sheet of asbestos;
- Wrap asbestos waste in heavy-duty builders' plastic (the grade of plastic must be at least 200 microns thick);
- Completely seal the package, using builders' tape or duct tape. Packages must be wrapped in manageable sizes for hand unloading;
- Waste must be carefully unloaded by hand to prevent the release of dust.

Asbestos must never be transported dry or unwrapped. Unless prior approval is obtained from the Waste Operations Supervisor it must not be unloaded by a tipping vehicle. If you do not follow these directions we may prosecute you under the *Local Government Act (1993)*. If you are unsure if the material you have to dispose is really asbestos please contact Council's Health and Building inspector on 02 6499 2222 for assistance.
